

OFFICIAL SWEEPSTAKES RULES

1. NO PURCHASE NECESSARY.

NO PURCHASE IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE DOES NOT AND WILL NOT INCREASE YOUR CHANCES OR THE ODDS OF WINNING.

2. GENERAL SWEEPSTAKES INFORMATION.

The “Community Survey” Sweepstakes (“Sweepstakes”) will consist of one (1) Sweepstakes drawing. To be eligible for the Sweepstakes drawing, eligible individuals must complete and submit entries for the Sweepstakes drawing, as set forth herein, during the specified entry period for the Sweepstakes drawing. The sponsors of the Sweepstakes are Town of Somers Recreation Department (the “Sponsors”). THE SWEEPSTAKES SHALL BE SUBJECT TO THESE OFFICIAL RULES, AND BY ENTERING, ALL ENTRANTS AGREE TO BE BOUND BY THE TERMS AND CONDITIONS CONTAINED HEREIN.

The entry period for the Sweepstakes drawing begins at 9:00am Eastern Standard Time (“EST”) on March 1st, 2018 and ends at 5:00pm EST on April 1st, 2018 (“Entry Period”). ALL ENTRIES MUST BE RECEIVED BY 5:00PM EST, ON THE FINAL DAY OF THE ENTRY PERIOD; ALL ENTRIES RECEIVED AFTER SUCH TIME WILL BE DEEMED INVALID, DISQUALIFIED FROM THE SWEEPSTAKES AND NULL, VOID AND OF NO EFFECT.

For the purpose of the Sweepstakes, an “Entrant” shall mean an individual who has successfully submitted a complete, valid and legitimate Sweepstakes entry, in strict accordance with these Official Rules.

3. ELIGIBILITY:

The Sweepstakes is only open to legal residents of the United States (except residents of Puerto Rico, all United States Territories and Possessions and overseas military installations). THE SWEEPSTAKES IS VOID IN ANY AREA OUTSIDE THE AREAS SPECIFIED ABOVE AND WHERE PROHIBITED BY APPLICABLE LAW. TO BE ELIGIBLE YOU MUST BE EIGHTEEN (18) YEARS OF AGE OR OLDER, AS OF THE DATE OF ENTRY, OR, IF YOU ARE UNDER THE AGE OF EIGHTEEN (18), YOU MUST RECEIVE PARENTAL CONSENT TO ENTER. Members, managers, shareholders, directors, officers, and employees of the Sponsors, each of their respective affiliates, subsidiaries, parent companies and agencies (collectively, the “Promotional Parties”) and their respective families and any individual or individuals living or residing in the household or residence of the individuals and parties, specified above, whether or not related, ARE NOT ELIGIBLE TO ENTER OR WIN. A PRIZE WON BY A MINOR IN THE JURISDICTION IN WHICH SUCH MINOR RESIDES WILL BE AWARDED IN THE NAME OF SUCH MINOR’S PARENT OR LEGAL GUARDIAN.

4. **HOW TO ENTER.**

A. **On-Line:**

1. Upon commencement of the Entry Period, survey invitations will be sent to potential participants inviting the potential participant to follow the link to the Sweepstakes website ("On-line Entry Site"), complete a survey and provide the potential participant's first and last name; street address (no P.O. Boxes), city, state and zip code; daytime telephone number; and e-mail address ("On-line Entry"). PARTICIPANTS IN THE SWEEPSTAKES, WHETHER VIA ONLINE ENTRY OR THE ALTERNATE MEANS OF ENTRY, ARE LIMITED TO **ONLY** ONE (1) ENTRY PER PERSON, PER HOUSEHOLD ADDRESS, PER E-MAIL ADDRESS. ANY ENTRY OR ENTRIES IN VIOLATION OF THE FOREGOING LIMITATION WILL BE DEEMED INVALID, DISQUALIFIED FROM THE SWEEPSTAKES AND NULL, VOID AND OF NO EFFECT.

B. **Alternate Means of Entry:**

1. As an alternate means of entry, you may submit a Sweepstakes entry by sending a 3x5 card or post card to:

The card or post card should include the following information about the Entrant:

1. First and Last Name;
2. Street Address, City, State and Zip code;
3. Day-time Telephone Number;
4. Date of Birth; and
5. E-Mail Address.

PARTICIPANTS IN THE SWEEPSTAKES, WHETHER VIA ONLINE ENTRY OR THE ALTERNATE MEANS OF ENTRY, ARE LIMITED TO **ONLY** ONE (1) ENTRY PER PERSON, PER HOUSEHOLD ADDRESS, PER E-MAIL ADDRESS. ADDITIONALLY, ENVELOPS CONTAINING A CARD OR POST CARD SHOULD CONTAIN ONLY ONE (1) ENTRY. ANY ENTRY OR ENTRIES IN VIOLATION OF THE FOREGOING LIMITATIONS WILL BE DEEMED INVALID, DISQUALIFIED FROM THE SWEEPSTAKES AND NULL, VOID AND OF NO EFFECT. IF MULTIPLE ENTRIES ARE INCLUDED IN ONE (1) ENVELOP, ALL ENTRIES CONTAINED WITHIN THE ENVELOP WILL BE DEEMED INVALID, DISQUALIFIED FROM THE SWEEPSTAKES AND NULL, VOID AND OF NO EFFECT.

2. If a dispute arises regarding who submitted the card or post card, the entry will be deemed submitted by the person whose name appears on the card or post card.

C. ALL ENTRIES BECOME THE PROPERTY OF THE SPONSORS AND WILL NOT BE ACKNOWLEDGED OR RETURNED. BY ENTERING THE SWEEPSTAKES, ENTRANTS AFFIRM THAT THEY HAVE READ AND ACCEPTED THESE OFFICIAL RULES.

5. **SELECTION OF WINNERS.**

- A. All Entrants will randomly be assigned a number. Winners from the Sweepstakes drawing will be selected in a random drawing on or about April 13th, 2018; there will be Five (5) winners in the Sweepstakes drawing. Winners from the Sweepstakes drawing will be notified by e-mail, certified mail and/or telephone. If any prize notification or prize is returned as undeliverable for any reason, an alternate winner will be selected, without any further notice.
- C. The total approximate retail value ("ARV") for the Sweepstakes drawing is Two Hundred Fifty Dollars (\$250).
- D. THE ODDS OF WINNING A PRIZE ARE DETERMINED BY THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED.

6. **TAXES.**

ALL FEDERAL, STATE, AND LOCAL TAX LIABILITIES, IF ANY, ARE THE SOLE AND EXCLUSIVE RESPONSIBILITY OF THE WINNERS.

- A. **GENERALLY.** All Prizes will be awarded. SPONSORS WILL NOT REPLACE ANY LOST, MISPLACED OR STOLEN PRIZES. Prizes are non-transferable, assignable and have no cash value. NO PRIZE SUBSTITUTION OR CASH REDEMPTION IS ALLOWED BY THE WINNERS. Sponsors reserve the right to substitute prizes of comparable value if the advertised prize becomes unavailable. All prizes are provided "as is" and without any warranty of any kind, whether express or implied, including, but not limited to the implied warranty of marketability and fitness for a particular purpose.
